

Art Contest

1. Eligibility: The VK Pediatric Dentistry Art Contest is open to all children residing in Northern Virginia and DC who **submit a drawing entry to art@smilewithvk.com signed by a parent or guardian.** The Art Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited. No purchase is necessary to enter or win. A purchase does not increase the chances of winning.

2. Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of **VK Pediatric Dentistry** as final and binding as it relates to the content.
